

## ***RULES AND CONDITIONS OF THE SUPPORTERS' STAND***

### ***Conditions of membership, access and permanence in the "Grada de Animación".***

The purpose of the "Grada de Animación" is to create a group of Club supporters who will continuously provide encouragement and support for the Club, both inside and outside the Stadium, and who will always behave in an excellent and ethical manner.

The undersigned, in his capacity as holder of the Club's special season ticket that gives access to the "Grada de Animación", accepts and gives his express consent to the basic obligations and rules of behaviour identified below:

1. Any person accessing the "Grada de Animación" must be at least eighteen (18) years old. If this is not the case, parental or legal guardian consent will be required.
2. Any person entering the "Grandstand" may be subject to inspection by Club security personnel and/or Police.
3. Any person accessing the "Grada de Animación" must undergo biometric access control, for which purpose, prior to obtaining the special "Grada de Animación" season ticket, they must provide the necessary fingerprint capture.
4. Any person accessing the "Supporters' Stand" must comply with any instructions required by the Club's security personnel and/or services.
5. Any person entering the "Supporters' Stand" with entertainment material to be displayed in the "Supporters' Stand", in addition to complying with the corresponding legal requirements, must be previously approved by the Club.
6. Any person holding a "Grada de Animación" season ticket must behave and behave ethically in an exemplary manner.
7. The undersigned expressly declares and guarantees that he/she is aware of the legal regime and internal regulations of the Club regarding the organisation and attendance at sporting events and, specifically, the provisions contained in Law 19/2007 against violence, racism, xenophobia and intolerance in sport (in particular, the conditions of access and permanence for spectators established in articles 6 and 7 of said Law and the commitment not to carry out acts or conduct set out in articles 2. 1 and 2.2 of the aforementioned Law); Royal Decree 203/2010, of 26 February, which approves the Regulations for the prevention of violence, racism, xenophobia and intolerance in sport; and the Club's Internal Disciplinary Regulations (which are available on the Club's website: <http://www.rcdespanyol.com/es/reglamento-disciplinario>).
8. Failure to comply with the obligations contained in section 6. above will imply, in addition to the consequences that may arise when the breaches may constitute a criminal offence, the immediate expulsion of the offender from Stadium facilities by those responsible for security at the Club or, where appropriate, by members of the Police, without prejudice to the

subsequent opening of disciplinary proceedings and the imposition of the corresponding sanctions (including the potential withdrawal of the season ticket without the right to any refund).

9. The special season ticket for the "Grada de Animación" is personal and non-transferable, regardless of the policy that the Club may adopt about season tickets corresponding to other areas of the Stadium. In this regard, the Club reserves the right to carry out as many internal controls as it deems appropriate to verify its correct use, requesting the ID of the season ticket holder or, in case of doubt, establishing the technical mechanisms that, at any time, it deems necessary to accredit the ownership of the season ticket, including those relating to automatic biometric systems. Non-compliance with this obligation by the holder or fraudulent use of the season ticket will entitle the Club to proceed to withdraw and/or cancel the season ticket.
10. The undersigned expressly declares and acknowledges that he/she does not have a criminal record of any kind. Where applicable, the Club may request and, if necessary, require the corresponding criminal record certificate from any holder of a special "Grada de Animación" season ticket.
11. The "Grada de Animación" is created with the fundamental aim and purpose of serving as an example and reference for other clubs and supporters of the way in which the Club's supporters support its colours. Consequently, the undersigned expressly accepts that, as a member of the "Grada de Animación", he/she must exhibit irreproachable conduct at any football stadium where he/she attends as a fan and member of the "Grada de Animación" and, in particular, at the Stadium, and must fully respect the regulations in force at all times. Therefore, he/she expressly undertakes to comply with the instructions that, at all times and especially during the matches, may be communicated to him/her by the employees of any sports club or the surveillance and security personnel of the same, collaborating with them in the location and identification of persons who infringe the legal regulations, disturb public order or engage in unsportsmanlike conduct.
12. Respect among fans is one of the Club's fundamental values. Consequently, the members of the "Supporters' Stand" are obliged to treat the other members of the stand with due respect, reinforcing the bonds of companionship and camaraderie. Insults, contempt, humiliation or any other form of disrespect or intimidation towards other supporters of the Club and/or fellow members of the "Grada de Animación" are expressly reprobated and prohibited, and may constitute grounds for direct expulsion from the "Grada de Animación" and withdrawal of the Club membership card without the right to any refund, without prejudice to the subsequent opening of disciplinary proceedings and the imposition of the corresponding sanctions.
13. The undersigned expressly declares, acknowledges and, where necessary, accepts that total or partial non-compliance with the provisions of these Rules (without prejudice to any criminal, civil or administrative responsibilities that may correspond to him/her) may result in the commission of a "Very Serious Infringement" (in the terms defined in the Club's Internal Regulations). Consequently, it may entail, among other sanctions, the automatic cancellation of the membership subscription without the right to any economic refund, as

well as the temporary or definitive expulsion of the member, without the right to any economic refund, as well as the temporary or definitive expulsion of the member, temporary or definitive expulsion from the Club, depending on the seriousness of the breach in question.

14. The undersigned, in his/her capacity as holder of a special season ticket for the "Grada de Animación", has the duty to take care of said season ticket. Consequently, in the event of loss, misplacement, theft or robbery, the undersigned must inform the Club as soon as possible. However, the issuing of said duplicate will require that, prior to this, no fraudulent use has been made of the Club's membership card. Likewise, it is expressly forbidden to make improper use of the Club's membership card, or to allow it to be used by a third party.
15. The undersigned expressly declares and guarantees that:
  - a. Not to have been the object of a sanction, final or precautionary, nor to be registered in the Central Register of Sanctions, for infractions in matters of violence, racism, xenophobia and intolerance in sport, in accordance with the provisions of Law 19/2007 against violence, racism, xenophobia and intolerance in sport and in Royal Decree 203/2010, of 26 February, which approves the Regulations for the prevention of violence, racism, xenophobia and intolerance in sport.
  - b. Have not been the subject of a sanction, final or precautionary, for infringements relating to the protection of public safety in connection with events, shows or sporting events.
  - c. Is not under criminal investigation or prosecution, nor have been detained for the commission of an intentional crime against persons, against freedom, against collective security, against fundamental rights or against public order.

16. In accordance with the provisions of current legislation on personal data protection, we inform you in relation to the processing of your data that you provide as a holder of the special membership card of the "Grada de Animación", will be processed by REIAL CLUB DEPORTIU ESPANYOL DE BARCELONA, SAD, in order to process your registration in the "Grada de Animación", as well as to manage your relationship with the same in accordance with the conditions of membership, access and permanence in the "Grada de Animación". Your data will be kept for as long as you are a member of the "Grada de Animación" and once you cease to be a member of the "Grada de Animación", they will be kept blocked for the period required by law for the attention of possible liabilities arising from the processing and during the period of limitation of the same. Once the period has expired, the data will be deleted. In accordance with the applicable legislation, among others, Law 19/2007 against violence, racism, xenophobia and intolerance in sport and Royal Decree 203/2010, of 26 February, which approves the Regulations for the prevention of violence, racism, xenophobia and intolerance in sport, and the Regulations regulating the general system of access and permanence in sporting events and shows organised or managed by REIAL CLUB DEPORTIU ESPANYOL DE BARCELONA, S.A.D. and disciplinary regime of members, season ticket holders and groups linked to the Club, your data may be communicated to the legally authorised Public Administrations and the State Security Forces and Bodies.

The legal basis for the processing of your data, as you have been informed, is the acceptance of the present Rules and Conditions of the Supporters' Stand, compliance with the applicable legislation, and your explicit consent to the processing of your biometric data, which you grant by signing this document.

You have the right to access your personal data subject to processing, as well as to request the rectification of inaccurate data or, where appropriate, to request its deletion when the data is no longer necessary for the purposes for which it was collected, as well as to exercise the right to oppose, limit the processing, data portability and to withdraw the consent granted.

17. By virtue of the present conditions, RCDE may withdraw the season ticket from the Grada de Animación area from those persons who, without justification, are absent from 5 or more matches, whether or not consecutively. This condition is expressly and reliably accepted by all those subscribers of the Grada de Animación area, who are not entitled to a refund of the amount paid.

In this context, the Season Ticket Holder in the Grada de Animación area may, where possible due to availability, be relocated to another area of his choice at the RCDE Stadium by paying the difference between the amount paid for the season ticket in the Grada de Animación area and the available seat of his choice.

18. **This registration is provisional.** The Club reserves the right to refuse admission to the Grada de Animación, and/or not to renew the Grada de Animación season ticket, when the applicant does not meet the requirements for access to the Grada de Animación. Non-admission to the Grada de Animación does not prevent the applicant from being a full member in any other sector, as long as there is no precautionary measure or disciplinary sanction by the Club that prevents this. If the membership is not finally approved, the season ticket holder may choose between:

**-Change to other areas of the Stadium: In this case, they will pay the corresponding monetary compensation, if there is a difference in price.**

**-Request a full refund of the amount paid, provided that the new member gives the season ticket to PAS, within the period notified by the Club when he/she was notified of the refusal.**

**And having read and understood the foregoing,** he/she subscribes to these Rules as a sign of acceptance of the terms and conditions set out in these Rules,
